Updated Information for Product Disclosure Statement

One Managed Investment Funds Limited ACN 117 400 987 (**OMIFL**) is the responsible entity for the Barings Liquidity Investment Strategy ARSN 677 466 034 (**Fund**). OMIFL in its capacity as responsible entity of the Fund has appointed Barings Australia Pty Ltd ACN 140 045 656 (**Manager**) as the investment manager of the Fund.

The purpose of this document is to update the product disclosure statement (**PDS**) and the Additional Information Booklet (**AIB**) for the Fund both dated 23 July 2024 with information which does not include any materially adverse information.

Concentration Limits

The Manager maintains a policy to adhere to the Investment Guidelines, including concentration limits and asset allocation as defined in section 5.5 of the PDS and section 3.5 of the AlB (**Guidelines**), with all calculations performed assuming an initial Fund principal balance of AUD\$200,000,000 (excluding the Private RMBS and Private ABS).

As such, in addition to movements in the market or similar events, the Guidelines may not be adhered to until the Fund has an initial principal balance of AUD\$200,000,000 (excluding the Private RMBS and Private ABS).

The paragraph headed 'Concentration Limits' in section 5.5 of the PDS and section 3.5 of the AIB are updated to be read as follows:

Concentration Limits

- Maximum 10% holding in any one security
- Maximum 100% RMBS
- Maximum 40% CMBS
- Maximum 40% ABS (other than RMBS and CMBS)
- Maximum 20% corporate bonds
- Maximum 20% Private RMBS and Private ABS
- Maximum 100% can be invested in cash or cash equivalents, including units in an exchange traded fund (ETF) or trust that solely invests in Australian dollar denominated deposits, issued by ADIs that are regulated by the Australian Prudential Regulation Authority

Until the Fund reaches a principal balance of AUD\$200,000,000 (excluding the Private RMBS and Private ABS) and otherwise due to movements in the market or similar events, the guidelines set out above may not be adhered to from time to time. In circumstances of movements in the market or similar events, the Manager will seek to bring the Fund's investments within the guidelines within a reasonable period of time.
